The Distinguished Service award is given to a business or agency that has supported NYS SkillsUSA.

- Step #1 Copy and distribute the attached application throughout your area. Once you have received all applications, select your Area SkillsUSA Distinguished Service Award winner.

- Step #3 All Area winners will be introduced and recognized at the Ceremony on April 24, 2024 during the Opening Ceremony. The Distinguished Service Award winner will then be announced during the event.
- Step #4 The NYS SkillsUSA Board will form a committee to review the Area winners and select a state winner.

- Area winner's paperwork **must be postmarked or emailed by March 15, 2025**



Nominator's Instructions

Nominator should submit to his/her NYS SkillsUSA Area Administrator Trustee:

- Nomination form
- 3000 characters or less, what has this person done to promote NYS SkillsUSA and why are they deserving of this award.
- In 2000 characters or less, please provide a short bio about the business. This might include: information about how the business or agency was started, how long it has been in business, were any of the employees NYS SkillsUSA members, what service they provide, any awards or recognitions they have received. This information is not part of the judging criteria. It will be used for promotional purposes only.

Criteria

This award will be presented to a business or agency involved in Career & Technical Education, who has helped NYS SkillsUSA through a school chapter.

Eligibility

Eligible individuals are businesses or agencies whose contributions have helped NYS SkillsUSA chapters. Contributions and achievements on which the nomination is based should have been made within the past ten years. The nominee does not have to be a paid SkillsUSA professional member.
